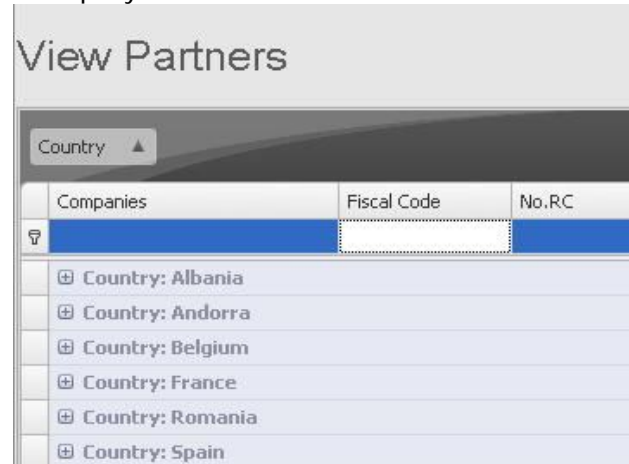

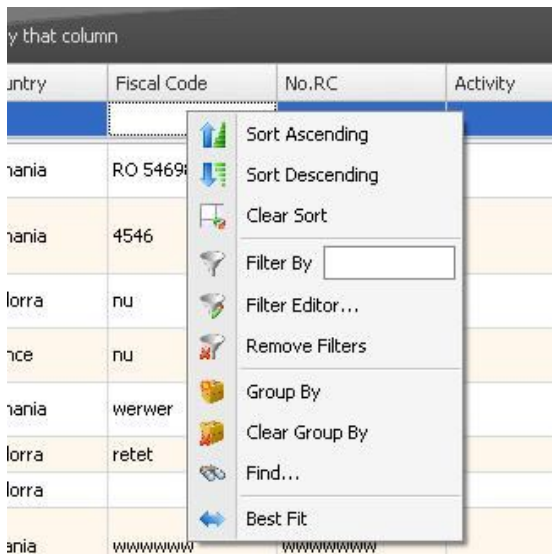
1. The bar "Drag a column header here"
